4. Details of our assessment

This was an unannounced routine site inspection visit by Waste Regulation Officer Joe Weatherley, to check that fridge/freezers brought to site are stored in accordance with condition (h) of table 4.7 in the site environmental permit (standards for handling and/or storage of waste with specified characteristics).

Condition (h) states that *"hazardous household waste shall be stored in sealed containers within a secure hazardous waste store"*. The site has a sealable shipping container in place for this purpose.

Hazardous household waste storage (fridge/freezers)





Condition 1.4.2 of the site permit states:

"A copy of this licence shall be kept available on site for reference when required by all site staff carrying out work under the requirements of the licence".

The officer could not see the site permit in the site office and staff members couldn't tell him where it is kept.

Action: Please ensure that a copy of the site permit is kept on site and the staff know where to find it.

Generally the site is clean and tidy and no problems were encountered during the visit.
