4. Details of our assessment

On the 30th of October 2024 NRW Officers Nathan Owen and Gareth Siney attended the Tyn Y Groes STW (CG0015401) we were accompanied by the North West Catchment Manager and the NW Operational Supervisor.

The weather on the day was dry and over cast, the catchment had received no rain in the days leading to the site visit.

Image 1 – inlet screen



The inlet screen was intact with no signs of defects or blockages.

Image 2 – filter bed



There was no visual issues with the filter bed operation, growth was very minimal.

Image 3 – Sludge tank.



The sludge tank on site was in need of emptying, DCWW explained there was a ground water issue in accessing the site which made it difficult to get a tanker on site in periods of wet conditions.

Image 4 – filter bed structure.



The filter bed structure was in poor state with the mortar failing in large sections, although from visual inspection the treatment process was not being compromised, it is quite clear maintenance/improvements further to the high tensile cables already in place are required.

Actions

- Empty sludge tank
- Carry out a risk assessment of filter bed structure to ensure its integrity to the treatment process.
