### 4. Details of our assessment

Routine monitoring sample taken on the 30 October 24 of the final effluent from the wastewater treatment works showed an exceedance for Iron.

The consented limit is 4 mg/l, the sample result produced a reading of 4.1 mg/l.

This is the 1st exceedance for Iron at this site within the last 12-months period. Based on the LuT and the site's sampling frequency, this result is classed as a LUT Exceedance.
