4. Details of our assessment

This was a routine, unannounced site inspection carried out by Waste Regulation Officer Joe Weatherley. The weather was dry and overcast. Upon arrival, the officer was greeted by a site operative who requested the officer sign the attendance log in the site office. The site diary was open on the desk and was up to date with relevant entries made. Part way through the inspection, the Site Manager arrived and accompanied the officer during the visit.

Several fridge/freezers were stored outside on site without weatherproof covering. The officer pointed this out to the site manager, who explained that suitable, weatherproof containers for the fridge/freezers had been sourced and would be in use on site as soon as possible.

Action: Please ensure weatherproof covering/containment for fridge freezers as per Annexe iii of the WEEE Directive.

Generally, the site is clean and tidy with all waste types segregated and clearly signed.
