4. Details of our assessment

This was an unannounced routine site inspection carried out by Waste Regulation Officer Joe Weatherley. The purpose of the inspection was to determine whether fridge/freezers were being handled and stored according to the permit condition set out in table 4.6 (h) of the site environmental permit.

4.6 (h) *Hazardous household waste shall only be stored in sealed containers within a secure hazardous waste store.*

The site has a weatherproof shipping container for this purpose.
