4. Details of our assessment

On the 01/11/2024 an NRW officer carried out a routine unannounced inspection on the

hydroelectric scheme (HEP) on the un-named tributary of the Hirnant at Ty Nant Farm, Penybontfawr, Oswestry, Powys.

The licence holder was not present during the inspection. The visit was undertaken to assess compliance of the HEP scheme in relation the abstraction licence MD/054/0001/074 and impoundment licence MD/054/0001/086.

The weather was dry and overcast at the time of the inspection.

Water was not being abstracted at the time of the inspection. Stones have been allowed to accumulate in the impoundment, which have blocked to compensatory flow notch, preventing it from working as intended. The stones and gravel need to be removed from behind the impoundment and placed to the downstream side of the structure so that they remain within the watercourse.

This breach of licence condition was however causing no impact because water was not being abstracted. This needs to be rectified before water is abstracted, and by the 11th Dec 2024.



The generator building was not inspected during this visit.

No other issues were found during the inspection.
