**4. Details of our assessment**

On 25 October 2024 a site inspection was carried out by NRW Officers Sally Wakeford and Michael Edwards and were accompanied on site by Andrew Wood (PCC). Officers has been requested by our Permitting Team to undertake a visit for surrender. Unfortunately at the time of the inspection the site was still operational and had not yet relocated to the newly permitted Eco Park site.

Whilst on site it was noted that the operations were well managed, only wastes allowed under the permit had been accepted, and the site was tidy and well organised. No non-compliances with the permit were noted during the inspection.

The site will be revisited once operations have moved to the alternative site.
