## 4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q3 (July - September) 2024 monitoring returns by Dunbia (UK) for activities at Cross Hands Meat Processing Plant, Cross Hands Business Park West, Llanelli SA14 6RF under permit EPR-BU8002IT.

### Q3 2024 Monitoring Returns

#### Emissions to water - Water 1 / 18/10/2024

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to discharge point W5 for Q3 (1 July - 30 September) 2024 were submitted to NRW on 18 October 2024.

#### Emissions to sewer - Sewer 1 / 18/10/2024

The returns for reporting of sampling and analysis of emissions to sewer to discharge point S1 for Q3 2024 were submitted to NRW on 18 October 2024.

- The monitoring data was sent within the Q3 reporting period, which is **compliant** with permit condition 4.2.3.
- The monitoring was conducted inside the Q3 monitoring period, which is **compliant** with permit condition 3.5.1.
- The monitoring returns submitted includes reporting of monitoring carried out in respect of the parameters and emission points specified in table S4.1 of schedule 4, which is **compliant** with the permit.
- Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified limits over the Q3 2024 reporting period.

**SCHEDULE 5 NOTIFICATION SUBMISSION**

On 16 August 2024, the operator submitted Schedule 5 notification containing a part A and B detailing an exceedance of ammonia at W5.

Table S3.2 point source emissions to water dictates that:

Ammonia shall not exceed:  
• **0.25 mg/l**

On 26 July 2024 ammonia was recorded at a value of 0.6mg/l - this reading has exceeded the ELV specified in S3.2. The operator provided the following explanation:

"Following receipt of the recent exceedance of ammoniacal nitrogen levels, an investigation was conducted to determine the cause. It was identified that a portion of the roof area currently drains into the yard, and birds nesting in this space have contributed to the elevated nitrogen levels through their droppings.

We have previously added the cleaning of this roof section to our maintenance schedule, with cleanings scheduled every six months. The last roof clean was completed end of February 2024. However, due to the ongoing nesting season, we have been unable to perform cleaning in July. The nesting season is expected to conclude within the next few weeks, after which the scheduled roof cleaning will be carried out immediately."

**Compliance Breach**

In accordance with NRW's compliance scoring guidance, a non-compliance score of **C3** has been recorded against sub-criteria IR3A.
