Environment Officer Eleanor Davies and Senior Environment Officer Gareth Davies attended site for a routine inspection. We were met on site by Leyton Shillibier (LS) who showed us around and explained the operations on site.

At the time of inspection there was a Crusher on site crushing and separating the larger material into various saleable sizes. The yard was clean and organized and the noise and dust on site were not greater than would be expected at such an operation. All activities were taking place on an impermeable pad.



There was a skip on the impermeable pad that contained the contaminating material such as plastic that had been removed from the inert waste.



The site was surrounded by a fence and had lockable gates at the front.

Environment Management System.

At the last inspection carried out by Jodie Medcraft in October 2017 it was stated that the EMS for site needed to be updated and a copy sent to NRW. LS stated that he believed the EMS had been updated as part of the updates carried out for the aggregate

quality protocol.

Please ensure that a copy of the reviewed and updated Environment Management System for the site is provided to Natural Resources Wales by Friday 7th December 2018.

Technically Competent Management

During the inspections of site on the 23 March 2017 and the 8 November 2017 it was highlighted that the current WAMITAB certificate for the site was out of date. LS explained that he had not yet managed to complete the qualification but that he was looking into asking the TCM for Cox Skips (Paul Denyer) to cover Wern Tarw as TCM also. Upon return to the office PD's WAMITAB certificate was checked. PD hold a certificate for the Transfer of Hazarsous waste only. As this does not cover the treatment of waste, PD would not be classed as technically Competent to cover Wern Tarw. This is a breach of condition 1.1.1 which states:

"The activities shall be managed and operated:

[...] b. by sufficient persons who are competent in respect of the responsibilities to be undertaken by them in connection with the operation of the activities."
