**4. Details of our assessment**

An unannounced inspection was carried out at Wogaston Closed Landfill permit number EPR/KP3198FQ on 25 October 2024 by NRW Officers Sally Wakeford (Senior Closed Landfill Officer) and Michael Edwards (Waste Regulation Officer).

The weather was clear and dry. No one was present at the site. Access was gained on foot through the southern boundary field. The gates to the site were secure to vehicular traffic.

The inspection was undertaken to familiarise the Closed Landfill Officer with the site, as it has been many years since it was last visited.

The Operator continues to hold a closed landfill permit, the original waste management licence was issued on 29 March 1996 for the landfilling of inert wastes. The permit allowed the following wastes to be deposited: topsoil, subsoil, brickwork, stone, concrete, clay, sand, silica and glass. According to our records, the landfill ceased the acceptance of waste prior to 31 March 2001, possibly during 1999. The site is now closed and in the aftercare phase until such time as the permit is surrendered.

Regular inspection records are available for the site. There are only a few records of non-compliances noted during the operational phase, including on 16/08/1996 it was noted that some wood, plastics and metal were mixed with inert waste.

The site is small, less than 0.35ha in area, and sits on a Secondary A aquifer. A small stream flows along the northern boundary of the site. And there are no gas receptors within 250m of the site.

During the inspection it was noted that the land is currently used as what could be described as a builders yard, containing materials used in the construction industry. There was no waste present. The surface of the landfill is restored to hard standing, and shows no signs of cracking or slippage suggesting the waste deposit is stable.

The stream along the northern boundary of the site was flowing, no odours were present and it showed no signs of being impacted by the landfill.

It is likely that this site could be suitable for low risk surrender. If you require further information on the steps required to surrender the permit, please contact Sally Wakeford.
