4. Details of our assessment

An unannounced site inspection was undertaken at Slade Cross Closed Landfill (EPR/UP3098FG) by NRW Officers Sally Wakeford (Senior Closed Landfill Officer) and Michael Edwards (Waste Regulation Officer) on 25 October 2024.

The weather was dry and clear however preceded by a period of rainfall.

This was a routine inspection to determine compliance with the environmental permit at the site. The site was accessible via a field gate.

The site is established with vegetation, and is currently being used for horse grazing, and storage of vehicles and containers. Levels of the site are varying, with some large mound to the centre.

No evidence of slippages or cracks/movement of the landfill mass were encountered. No evidence of leachate outbreaks, landfill gas odours or any unusual vegetation die back were encountered.

The stream flowing to the side of the landfill was observed, the water was running clear and exhibited no odour. Other ditches around the site contained no run off.
