## 4. Details of our assessment

A routine final effluent sample collected by Natural Resources Wales (NRW) from Pentregat Housing Act Works on 15 October 2024 was found to contain >223mg/l Biochemical Oxygen Demand (BOD) when the permitted limit is 150mg/l. A category 3 non-compliance has therefore been recorded above. A category 3 non-compliance represents a non-compliance which has the potential to have a minor or minimal impact or effect on the environment, people and/or property.

In response to the above non-compliance, NRW ask Ceredigion County Council (CCC) to investigate and explain why the BOD failure occurred on the 15 October 2024 and confirm what measures will be taken to prevent a recurrence by no later than the **09 January 2025**. During previous communication, CCC stated that a full site survey would be undertaken at Pentregat Housing Act Works during the week beginning the 22 April 2024. A detailed report was due to be produced following this site survey. NRW therefore also ask CCC to share the full site survey report with NRW by the **09 January 2025**.

## Important information
