We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

On the 23rd January 2024 a Sampling Officer from Natural Resources Wales attended Cefn Carnau Uchaf, Thornhill, Caerphilly Mountain CF83 1LX to undertake final effluent discharge samples on their Package Sewage Treatment Works. Permit Number AN0295601 .

Breaches of permit condition:

Composition

7. The discharge shall not contain more than:

(i) 20 milligrammes per litre of biochemical oxygen demand (measured after 5 days at 20C with nitrification suppressed by the addition of allyl-thiourea.

Justification

A sample was taken on the 23/01/2024 as part of routine monitoring. Sample results confirm that The BOD : 5 Day ATU was 21.5 milligrams per litre. The maximum Parameter limit is 20.0 milligrams per litre. This is a breach of 1.5 milligrams per litre.

Actions required by date specified:

- Inspect the Package Sewage Treatment Works.
- Produce an investigative report highlighting the reason for failures.
- Bring the Package Sewage Treatment Works into compliance with Permit Conditions.

The above actions are required by the 26th December 2024.
