4. Details of our assessment

The site was inspected by Cathrine Kiely (Senior Officer, Conwy) and Nathan Owen (Environment Officer, Conwy). Also in attendance from DCWW was North East Catchment Manager and Area Supervisor.

The WWTW is undergoing construction work by JN Bentley Ltd and so we were also accompanied by their Site Supervisor and shown a health and safety induction presentation prior to entering the site.

The weather during the time of the visit was dry and had not been raining prior. The storm

tank was empty.

The flow monitor into the works showed 9.96 l/s during the time of visit.
The site is visited daily by an operator for maintenance.

There was significant work going on on site including installation of a new storm tank, sludge storage tank and SAF plant.

The sludge storage will be diverted to the new sludge storage tank which was anticipated to go online soon. This will mean that the current sludge beds on site will be made redundant.

Action

1) There was a small leak on the wall of the storm tank which will need repairing. NRW request that the repair is completed by **9/12/24**



2) Significant grass growth on the 3rd filter bed could impact on the efficiency of the treatment process. Please ensure the site operator keeps the filter beds maintained as part of their daily checks.



3) Although no leaks were found on the filter bed walls they were in a poor state of repair. Are there any improvement plans for the filter bed walls?
