4. Details of our assessment

Natural Resources Wales (NRW) Enforcement Officer apprentice Mark O’GORMAN, NRW Officer Chris BURGE and NRW Officer Greg GARDNER attended Rhymney HWRC, Lawn Industrial Estate, Rhymney, NP22 5PW, at 11:00am on Tuesday 5th November 2024 to conduct an unplanned site inspection of Permit site EPR- QP3899FY. The weather conditions were dry at the time of visit. The site was closed at the time of the visit, but visibility into the site was good and unobstructed.

PERMIT INSPECTION

At the time of the inspection the site was not operational and closed to the public. No staff were present. NRW officers were able to see far into the site from the main gate and surrounding fencing. The general housekeeping of the site was in a clean and tidy state. There was no waste outside of designated containers or the permitted boundary. The site was securely closed, preventing access during non-operational hours. It is evident that the site has designated containers to separate types of waste.



Image 1 shows the main gate securely closed with appropriate signage.



Image 2 show the clean and tidy condition of the site. No waste present outside of designated storage units.



Image 3 shows secured storage units with appropriately stored refrigerators.

WASTE ACTIVITIES

All waste storage containers were clearly marked, and signage was in place to inform members of the public what each bin contained.

The drainage appeared to be working efficiently at the time of the inspection.
