4. Details of our assessment

Archwiliad dirybudd rheolaidd o gynllun trydan dŵr ar y Clochnant, lednant yr Hirnant, yng Nghlochnant, Penybontfawr, Powys.

Roedd deilydd y drwydded ar y fferm yn ystod yr arolygiad ond ni aeth gyda'r swyddog. Cynhaliwyd yr ymweliad i asesu cydymffurfiaeth â'r cynllun trydan dŵr mewn perthynas â thrwydded tynnu dŵr WA/054/0001/0096 a thrwydded cronni dŵr MD/054/0001/001. Roedd

y tywydd yn sych ac yn gymylog ar adeg yr arolygiad.

Roedd y llif cydadferol yn gweithredu fel y'i dyluniwyd gyda dŵr ychwanegol yn llifo dros ben y cronïad.

Nid oedd unrhyw echdynnu yn digwydd gan fod y tyrbin yn aros am gydrannau panel rheoli newydd.

Routine unannounced inspection of hydroelectric scheme (HEP) on the Clochnant tributary of the Hirnant at Clochnant, Penybontfawr, Powys.

The licence holder was on the farm during the inspection but did not accompany the officer. The visit was undertaken to assess compliance of the HEP scheme in relation to the abstraction licence WA/054/0001/0096 and impoundment licence MD/054/0001/001. The weather was dry and overcast at the time of the inspection.

The compensatory flow was operating as designed with extra water flowing over the top of the impoundment.

There was no abstraction taking place as the turbine was waiting for new control panel components.
