4. Details of our assessment

CARS form generated following site visit to Cefn Graianog quarry on the 15/11/24 at 15:00.

Natural Resources Wales Environmental officer from the Meirionnydd and Dwyfor team met with the site manager from Tudor Griffiths Ltd & Ellesmere Sand & Gravel Ltd.

The Site manager showed the officer around the site. Currently all water on the site is recycled via a number of lagoons. 2 at the top of the site and 2 and the bottom prior to the

gravel and sand that are washed. The volume at the top of the site can be adjusted by adding water from the bottom into the process which will increase the amount in the top lagoons. Currently 1 is offline but will be brought into action soon.

The permitted discharge from the site is currently capped and not in use. The site is not looking to surrender the permit as they may use it in the future.
