4. Details of our assessment

Natural Resources Wales Senior Industry and Waste Regulation Officers Carter Shone and Paul Challender visited Knauf Insulation Limited, Queensferry Mineral Fibre Works, Chemistry Lane, Queensferry, Deeside, Flintshire, CH5 2DA at 1000 on the 7th November 2024. This was an announced inspection as part of a site familiarisation.

Permitted activities.

The officers were given a full tour of the installation including the processes, permitted monitoring points and the CEMS system.

No issues were identified in relation to permitted activities.

Emissions to Land, Air and Water.

The operator informed the officers that the sulphuric acid scrubber has now been installed connecting to emission point G. It is not currently operating as an acid scrubber and no acid has been added.

This will require a permit variation before use. Any use before permit variation determination could lead to compliance scores.

Emissions of substances not controlled by emission limits.

During the inspection the operator was asked to demonstrate the penstock system for the north-west half of the site. The control panel that operates the 'L4' pen stock was not working and, the operator could not identify if it was left open or close.

This compromises the containment of the site as pollutants could potentially be released through the drain without any prevention, resulting in the following score:

Score: (IR3B) Emissions of substances not controlled by emission limits. Permit Condition 3.2.1.

Compliance Score C3.

Action: Provide a copy of the preventive maintenance schedule for the penstock systems and ensure that they are all operational.
