4. Details of our assessment

On the 7 November 2024 you accompanied us on an inspection of Birchgrove Road Sewage Pumping Station which has a permit to discharge in emergency conditions only. It was dry at the time of the visit and there had been no rainfall in the days preceding.

Birchgrove Road SPS is permitted to discharge to the Nant Glais via a 9" outlet pipe in emergency situations only. These are the only permit conditions on this permit, issued in 1988.

Warning alarms are triggered by float switches. The float switch that activated a high level alarm

was located below the level of the discharge pipe, meaning you would be notified well before a discharge to the environment occurs.

Water marks on the side of the tank suggested that the tank rarely filled much higher than the levels we saw, which was far below a level that would trigger a discharge.

We could find no history of issues or reported spills from this site in our archive.

You informed us that the site is subject to regular maintenance, having had a replacement float in 2020 and replacement pump in 2022.
