## 4. Details of our assessment

On the 12<sup>th</sup> November 2024 an announced site inspection was undertaken by NRW officers Phil Harper and Rebecca Harwood, Senior Industry & Waste Regulation.

The purpose of the visit was to inspect perimeter groundwater and gas monitoring boreholes in preparation for a groundwater sampling campaign which is planned to take place in early 2025.

### Leachate Tank

Vegetation has been cleared from where the roof of the holding tank meets the concrete structure. However, further vegetation was visible. NRW is of the understanding that the vegetation has grown back since being cleared.

**Action 1:** Continue to undertake maintenance on the tank to ensure the integrity of the tank is maintained

Clinical waste bins which were observed on the site during an inspection on the 1<sup>st</sup> May 2024 have been removed from the site.

### Perimeter Monitoring Wells

Perimeter monitoring wells for groundwater and gas were inspected during the visit. Some boreholes were found to be blocked, therefore, it was not possible to assess internal water levels.

The operator stated that boreholes would unblocked following the visit.

**Action 2:** Unblock boreholes and check the internal water levels by the 20<sup>th</sup> December 2024.

**Action 3:** Notify NRW when this action has been completed.
