This compliance assessment report is being produced following a review of the waste returns and technically competent manager qualification for Glaslyn Workshop.

W1A - General Management - Permit Condition 1.1.4

Your permit states that you must comply with the requirements of an approved competence scheme. The continuing competency of the site Technically Competent Manager (TCM) Arvydas Kazlauskas has been assessed and is in date, with an expiry of 10th May 2026.

W3G - Fire - Permit Condition 3.4.1 - Action Only

Your permit states that the operator shall manage and operate the activities in accordance with a written fire prevention plan using the current, relevant fire prevention plan guidance. Currently, Natural Resources Wales does not have a copy of your sites Fire Prevention and Mitigation Plan (FPMP). This plan should be developed using the current guidance and made available to NRW or review.

A review of the sites waste returns has been conducted and all returns due have been submitted to Natural Resources Wales. The next waste returns, for 2024, will need to be submitted by the end of January 2025.
