This was an announced site inspection undertaken by David Ellar and Sally Wakeford of Natural Resources Wales and accompanied on site by manager Sonia Jenkins.

During the inspection it was noted that there are good management practices including waste segregation and litter control.

Infrastructure

The entirety of the site is made up of an impermeable pavement in line with **condition 2.1.2** of the Environmental Permit. During the inspection it was observed that the concrete was in good condition with no signs of cracks or deterioration.

Storage of waste

During the inspection it was noted that all waste on site was stored within sheds, and within bays following physical treatment in line with **condition 2.1.1** of the environmental permit. No issues were identified with the waste types stored on site, with no indication of non permitted waste types being accepted onto site in line with **condition 1.2.1**.

Staff Training

Sonia Jenkins is the TCM for the site. The current continuing Competence certificate expires in 21/12/2019.
