A routine site inspection was undertaken on Thursday 29th November 2018.

The aim of the inspection was to assess compliance with the Environmental Permit for the site. On this occasion, no breaches of the permit were recorded. The following observations were made:

### **Previous Inspection**

During the previous inspection (13/12/17 - CAR ref: NRW0032618) a number of non-compliances were recorded. These non-compliances were attributed to a number of areas including, but not limited to, site security, pollution prevention, drainage and record keeping (site diary).

Generally, there has been a large improvement to operations on site.

### **Observations**

Site security has been improved and fencing has been erected on the rear of the site. The site now appears to be fully secure, making access from a nearby footpath less likely.

An inspection of the site boundary revealed that litter did not appear to be escaping from site, as had been noticed in my previous inspection.

Drains outside the site were free from silt and appeared to be well maintained. Operations do not appear to be impacting on the local amenity and the access areas were free from mud/silt and other debris.

In my last inspection I noted that a significant quantity of inert waste was stored outside, to the rear of the site, with little or no measures in place to prevent potential silt pollution (rainwater run-off) in a nearby stream.

The drums and containers previously stored on unmade ground have been removed.

### **Waste Exemptions**

Our records indicate that there are no waste exemptions currently registered at the site (or in building currently used for maintenance). Information on waste exemptions, including the page for registering waste exemptions, can be found on our website;

### **Environment Management System**

It was agreed on site that a review of the Environment Management System would be undertaken to clarify the position over certain waste codes that are not included in the Environmental Permit. I will review this matter and provide a written response at a later date.

### **Summary**

Overall, operations have improved since the last inspection and no non-compliances were recorded during my inspection on Thursday 29th November 2018.

As mentioned on site, I advise you to seek advice and guidance from a Health & Safety professional regarding the storage of skips. Although skips were no longer stored three-high, as had been witnessed in my previous inspection, I still have concern over the storage of skips on the bank by the river, now stored two high. This is unmade ground and it appears if there is water draining over this area, potentially making it uneven.
