## 4. Details of our assessment

Unannounced site inspection carried out by Michael Edwards of Natural Resources Wales, accompanied on site by operations manager.

### **General Management - W1A.**

With the implementation of the new Workplace Recycling regulations, the site has provided skips near the entrance gates for members of the public to access. As discussed on site, the operations need to be included in a written management system that reflects the current site activities as required under condition 1.1.1 (a). The EMS is considered a live document and can be altered to the needs of the business.

**Action** - Please update the current EMS to reflect the current operations on site and provide a copy to Natural Resources Wales.

### **Waste Operations - W2A, W2C & W2D**

During the inspection it was noted that the activities on site were in line with the conditions of the issued permit, under **condition 2.1.1** and schedule 1 **table S1.1**. With waste operations on site limited to sorting and bulking at the time of the inspection.

All wastes were stored on an impermeable surface with sealed drainage. However, two drains at the rear of the site where there is significant traffic were blocked. As discussed on site, ensure that ongoing maintenance of drains is undertaken to ensure that they are kept clear.

Action - Ensure that routine maintenance is undertaken to maintain sealed drainage system.

The civic amenity site was well run with all wastes stored within appropriately sign posted bins and containers with staff on hand to direct members of the public to the correct areas. Gas bottles were stored within a locked cage on site.

All operations on site were within the permitted boundary as per **condition 2.2.1. With waste types identified during the inspection in line with condition 2.3.2 (a) listed within Schedule 2 table S2.1 .**

### **Waste Emissions - W3C**

During the inspection no odour were identified outside of the site at a level likely to cause a nuisance to local residents or businesses as required under **condition 3.3.1.**
