I attended the location with my colleague Ffion, only to find the scheme had not been implemented. As per Condition 9.11 of the permit, this permit is now no longer effective for this abstraction. I recommend you complete form WRF: [Natural Resources Wales / Apply to cancel your water abstraction or impoundment licence](#) in order to revoke the license (this is a free process). If you wish to construct the proposed scheme, you will need to apply to vary permit and extend this clause.
