4. Details of our assessment

This CAR form also relates to Impoundment: WA/055/0007/002

I attended the site on 4th July 2023. There was abstraction taking place, though flows appeared to be low. Site appeared to be as drawn. Unclear if maintenance was required to ensure flows are regulated correctly through the sluice or if it was deliberate - I would advise this is checked regularly to maintain compliance. Unable to locate/access discharge

point as Mill was closed at time of visit. Given volume of abstraction, and non-consumptive use, a C3 breach has been recorded due to abstraction when below the Weir level (as laid out within the permit).
