Technically Competent Persons.

During the inspection, evidence was provided for Peter Harts' WAMITAB certification. Can you please confirm with me once you have completed the continuing competence.

Environmental Management System and Fire Prevention and Mitigation Plan.

During the inspection we discussed that the site **must** have an EMS and FPMP that reflect on site activities both of which outline what procedures are in place to minimise the risk of pollution. Currently the site is using an EMS and an FPMP created by the previous operator (issues with the FPMP have been highlighted in CAR form *PB3490HV_CAR_NRW_0034094*).

We understand that the site is looking to to apply for a variation in April 2019 and this will require the operator to produce an EMS and FPMP as part of the application, however, under the conditions of the permit the site is required to operate as outlined in the specified documents.

This has been scored as a **category 3** breach of permit **condition 2.3.1. a** of the permit.

Action - In the interim before the variation is applied for, an updated EMS and FPMP must be submitted.

Site Infrastructure

No wastes were stored outside during the inspection. As discussed, should you wish to do this in future you will need to ensure that the surfaces are made impermeable in line with the conditions of the permit.

Odours

Odours were not detected on site during the inspection, however the operator confirmed that they had noticed odours from the DCWW site located adjacent to the site. These incidents have been recorded by the operators. As discussed you may wish to inform the local environmental health team of these odours so that are recorded as incidents officially.
