On the 5th of August 2018 Environment Officers conducted a routine inspection of the Abstraction Licence **WA/056/0036/001** and Impoundment Licence **WA/056/0036/004**.

At the time of the inspection the watercourse was in low flow conditions due to a long period of dry weather preceding the inspection. There was no abstraction taking place and no water was flowing over the coanda screen.

The structure has previously been measured and our Hydrology department confirmed that it is compliant with the conditions of the licence, although the measurements do not match those on the plans attached to the licences.

The Hands off Flow notch (HoF) was partially obstructed by an aggregation of rocks near its entrance during our inspection. It is not believed that this was done deliberately, however, be aware that it is a condition of the licences to ensure that the HoF is regularly maintained to avoid any blockages occurring. Failure to do so is a breach of conditions and an offence under the Water Resources Act.

The fish pass is currently not compliant as it would not currently be possible for fish to move upstream. I will liaise with our fisheries officer and arrange a visit to discuss how to address this problem.



Actions

Please send abstraction records for the last 2 years. **Complete within 28 working days.**

Ensure the HoF notch remains clear of all stones and rocks. **Regularly maintain the HoF notch even when no abstraction is taking place.**

I will arrange a visit with our fisheries officer to discuss solutions for the fish pass and bank erosion.
