## 4. Details of our assessment

Please note this CAR form also relates to Impoundment WA-056-0053-012

I attended site on the 24 July 2024, the weather was light showers and warm.

On arrival there were roofers at the property, who advised no one was presently at home so I proceeded through to the abstraction point.

The scheme was as shown on the permit, with the HoF notch clear apart from some minor debris that had started to build up behind it.

I proceeded down to the discharge point where I was unable to identify a screen on the discharge, as required by the permit, though the flows from the scheme were suitably offset that it was very unlikely to have any impact on fish/eel migration at this time. Please ensure a screen is installed no later than the 17th Oct 2024 and this is evidenced with a photograph to myself or the South Powys Environment Team by e-mail or post (whichever you prefer).
