On the 8th of August 2018 environment officers conducted an inspection of abstraction permit **WA/056/0053/005** and impoundment licence **WA/056/0053/016**.

A long period of dry weather preceded the visit and so the inspection was conducted under low flow conditions. No abstraction was taking place, water was not flowing over the coanda screen. The Hands off Flow notch (HoF) was well maintained with no blockages or obstructions.

The structure was measured and our Hydrology department confirmed that it is compliant with the conditions of the licence.

I will liaise with our fisheries officer and check that he is happy with the state of the fish pass. In the meantime could you please send me 2 years worth of abstraction data within **28 working days**.

Illegal Abstraction

Whilst we were on site an illegal abstraction was identified upstream; piping water from a small tributary away from its natural course to enter the Nant Cwm-du above the hydropower weir. This has resulted in a small section of the unnamed tributary drying up completely prior to its natural confluence with the Nant Cwm-du.



Actions

Remove the illegal abstraction pictured above and allow the unnamed tributary to follow its natural course - Complete by 16/10/2018

Submit 2 years of abstraction data to the contact details below - Complete 28 days.
