4. Details of our assessment

This CAR form also relates to Impoundment License WA/056/0053/017

On 20 July 2023 myself and colleague Laura Gregory attended the scheme for inspection. On arrival the scheme was abstracting but the Hand of Flow (HoF) notch was partially obscured by debris, restricting the downstream flow. There was no fish easement in place. We took photos and measurements before heading to the next scheme.

At the outfall the keys were in the door to the shed, so I entered and took photos of the meter. The turbine was operating at the time of visit. The discharge outfall was spraying quite significantly, which suggests either an issue or blockage within the pipe, and I recommend further investigations to ensure no issues. There appeared to be a screen of adequate sizing within the pipe.

This CAR is being issued with a warning as the HoF notch was partially blocked, reducing the volume of unobstructed flow to the watercourse. This is contrary to the license, condition 9.5. It does not appear to be deliberate, but regular maintenance of the schemes will ensure no additional blockages.

There is no fish easement, as specified by the license condition 9.8. I advise you contact NRW to discuss a proposal that should be implemented at the earliest opportunity.

Please also supply NRW with the last 12 months of abstractions returns (this can be done via the website) no later than 13 September 2023.
