A routine site inspection was undertaken on Wednesday 5th December 2018.

### **Operations & Security**

The site is considered non-operational and is currently not accepting, storing or treating any waste materials. The plant, initially erected for the processing of materials to produce aggregates, has been dismantled fully and continues to be non-operational.

The site appears to be kept secure although a representative on site did allude to a previous break-in. Please ensure site security is maintained, even if the site is non-operational. The site is occupied by City and County of Swansea.

### **Change of Use**

The City and County of Swansea are currently storing a number of empty skips (large skips and roll-on/roll-off). An inspection of these skips revealed that they did not contain any waste.

Should the council wish to use the yard for the storage/treatment of waste, they must do so in accordance with the conditions contained in the Environmental Permit. Responsibility for permit compliance still lies with United Recycling Aggregates Limited, as the permit holder.

### **Permit Surrender**

It is noted that it is likely that the Environmental Permit will be surrendered (as opposed to being transferred, as was previously discussed).
