Schedule 4 – Emissions and monitoring

Table S4.1 Leachate level limits and monitoring requirements require leachate levels in monitoring wells to be maintained at or below 2m.

The Schedule report of permit breach for leachate level in-well, detailed in self-reported table below dated 29-11-2024 at 3.32m, shows this is over the 2m permit limit. The score for this breach is a CCS3 minor breach.

ACTION: Please ensure current pneumatic pump is replaced with an electric pump as in the schedule notification response and is adequate for levels encountered. Part B of the Schedule notification stated the following:

Chamber- a formed a gel like substance inside which keeps on blocking pumps, leading to very frequent pump breakdowns.

FCC plan to install an electric pump with more power in the chamber in attempt to break up the substance and clear the backlog of liquid.

Consider de-silting the well and please ensure access to leachate wells and functionality is maintained at all times. Continue pumping and re-measure and report leachate head in 14 days' time to check for compliance.
