4. Details of our assessment

A routine site inspection was undertaken on Thursday 28th November 2024. Present at the time of the inspection were: David Morgan (Natural Resources Wales), James Giddings, Brian Giddings (Fordpad).

The following observations were made during the inspection:

Waste Storage

All waste on site appeared to conform with the list of acceptable wastes in the Environmental Permit. Operations are contained within the building resulting in very low potential for impact on the environment and local amenity. Wastes were clearly segregated.

It was noted that at the time of the inspection, the baler for cans was not working. Please ensure all breakdown of plant and equipment are recorded in a site diary if those breakdowns/faults may result in a potential breach of your Environmental Permit (e.g. having to store volumes of waste above those stated in your permit due to plant/equipment breakdown). There did not appear to be any impact on operations due to the baler being temporarily out of use.

Technical Competence & Records

Certification of technical competence was provided for inspection and confirmed that the technical competent manager's 'Continuing Competence' was up to date and next needs to be renewed in 2026.

Copies of the Environmental Permit and Management System were viewed in digital format. You should consider printing copies of these documents so they are easily accessible to other members of staff at all times.

Waste Consignment Notes for lead acid batteries were provided and appeared to contain all relevant and necessary information.

No non-compliances were recorded during the inspection. On Thursday 28th November 2024, operations, infrastructure and records were all assessed as being fully compliant with your Environmental Permit.
