4. Details of our assessment

The quarterly reports for the emissions to air and sewer for Q2 (April -June) and Q3 (July – September) 2024 were received by NRW on the 25 July and 24 October 2024 respectively.

Q2 and Q3 reports were received within the permit specified reporting period. All effluent releases to sewer over this period are compliant with the permit. Q3 air emission were within the limits specified in the permit.

The Q2 emissions to air report showed one non compliance as well as a note to say that bag filters with holes were replaced.

A visible release of particulates is a breach of permit condition 2.2.1.3 and a category 3 non compliance.
