This CAR also records a site visit made by NRW Officers to Lamby Way landfill site on the 3rd and 4th of October 2024. NRW Officers in attendance were: Brigid Armstead, Mostyn Wall, Susan Francis and Sally Wakeford. NRW Officers were escorted by representatives from Cardiff Council and Infinis Energy. The purpose of the site visit was to introduce a new regulatory officer from NRW, undertake an audit of the sites infrastructure and review the site under the national Landfill Emission Reduction Project (LERP). The site visit was followed by a request for further information by email. This information has been received and a further CAR will be sent in due course.
