4. Details of our assessment

This report relates to a site inspection of Holythorne B Pumping Station in Crofty, on 22nd November. The weather was dry and had been in the week leading up to the inspection. This permit allows for discharge of both storm sewage and emergency, both are discharged from the same point, discharging onto marshland at low tide and the Loughor Estuary at high tide.

The SPS has a wet well which appeared to have a capacity above the required 10.95m³ storm storage and a small dry well used for inspection purposes. You confirmed that duty, standby and assist pumps were in place, as referenced in the Pumping Station Key Performance Measures (PSKPM) which forms part of your permit. Flows into the chamber were very minimal and sewage levels were low. The chamber appeared to be clean and clear of debris.

Any storm or emergency overflows occur at a CSO chamber located some 45m east of the SPS, as required by the permit. There was a 10mm basket screen in place above the discharge point alongside the Event Duration Monitor (EDM). The screen had a small amount of rag on it but was mostly clear.

According to the annual data you submit to us, the event duration monitor recorded 7 spills in 2023 and it was operational for 99.94% of the time. Once the number of spills exceeds 14 an investigation into the exceedance must be carried out, as described in the permit.

We did not identify any non-compliances during our inspection.
