4. Details of our assessment

This was a routine, unannounced site inspection, carried out by Waste Regulation Officer Joe Weatherley. The weather at the time was wet and overcast. Upon arrival the officer was greeted by a site operative who accompanied him during the inspection. The officer inspected the site diary and found it to be up to date with relevant entries made.

The site permit was not visible in the office and accessible to staff. Condition 1.1.3 of the permit states:

"Any persons having duties that are or may be affected by the matters set out in this licence shall have convenient access to a copy of it kept at or near the place where those duties are carried out"

Action : Please ensure a copy of the site permit is visible and accessible to site staff at all times.

Generally, the site is clean and tidy with waste types segregated and clearly signed. Besides the point made above, there appear to be no issues with this site.
