3. What will happen next?

4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales accompanied on site by site operator.

Permitted activities (W2A)

Activities undertaken whilst on site were in compliance with the issued permit under **condition 2.1.1.**

However, as discussed on site, there are some wastes that have been stored on site in excess of 1 year.

Under **condition 2.1.1** and **table 2.1**;

wastes shall be stored for no longer than 1 year prior to disposal and 3 years prior to recovery.

The operator confirmed at the inspection that a trommel was to be brought onto site to begin the removal of wastes stored on site in exceedance of the above time limits.

Action - please provide NRW confirmation when this activity begins.

Operating Techniques (W2C)

At the time of the inspection the operator was in the process of removing oils from site, it was noted that some spillages had occurred with waste oils visibly flowing on the concrete

pad to the drain nearest the entrance of the site.

As discussed, the operator is required to ensure that spillages are dealt with in an appropriate manner as described in **condition 2.3.1** and **table 2.3**.

Waste ELV's were stored on impermeable surfaces with sealed drainage as required under **condition 2.3.1**. However, as discussed during the inspection, there are large sections of the yard that are in need of maintenance and drains required to be cleared as evidenced by the pooling of water in some areas.

Action - ensure that maintenance of the impermeable surface and sealed drainage system is upheld to ensure that wastes are stored in accordance with the permit.
