This Compliance Assessment Report (CAR) follows a routine inspection at Bryn Posteg gas plant.

The Site Manger and Environmental Technician accompanied NRW officers during the inspection.

The new landfill gas engine, installed April 2024, was operational with no known issues.

There were no landfill gas odours observed in the gas utilisation compound.

This permit will be audited by NRW's Landfill Emissions Reduction Project (LERP) Team in the future.
