4. Details of our assessment

This Compliance Assessment Report (CAR) follows a routine site inspection of the composting facility that is operated under a waste operations environmental permit CB3834RQ.

No composting operations were currently being carried out. The operator has placed the operation into a mothballed state and waste has not been accepted into this permitted operation for some time. The operator states that it is highly unlikely that composting operations will resume in the future.

NRW reminds the operator that although this permit is not in use, NRW will still require the payment of annual subsistence fees. The operator may wish to surrender this permit to remove the requirement to pay this annual fee and submit nil returns. The operator should engage with their regulating officers on how to proceed if they decide to surrender the permit.
