4. Details of our assessment

A site inspection of Bethel Construction Limited was undertaken on Friday 29th November 2024.

The purpose of the inspection was to review the current status of the site, and operations, following the sale of land in recent years. Bethel Construction holds an Environmental Permit (ref: EPR/FB3997TA) at this site.

Site Security

The site itself remains secure with high boundary fencing and locked gates. At the time of the inspection, construction workers were on site completing house building work.

Site security has been assessed as compliant as the site itself appears to be locked out of hours in order to prevent unauthorised access.

Site Operations

Bethel Construction Limited applied for, and were issued with, an Environmental Permit to deposit waste on site for the purpose of recovering land as part of a building development.

This activity has not taken place. As the land is now owned by a different individual/business you must consider either transferring, or surrendering your Environmental Permit.
