### 4. Details of our assessment

Following the issue of the permit, NRW local Environment Officers hosted a discussion with the permit holder on the 3rd December 2024.

The aim of the discussion was to talk through the permit and the improvement conditions and to obtain an update on the discharge location.

The treated effluent is still currently being discharged via the existing soakaway. It was

explained that this is a breach of the permit conditions, as this location is different to the location stipulated in the permit.

However, it was explained to NRW that the permit holder is in the process of obtaining planning permission to upgrade the existing effluent package treatment plant (PTP) and until this is obtained, the discharge will continue to discharge to the soakaway and the effluent treatment tank will regularly be emptied - minimum of once a month.

Improvement condition: discharge to achieve the higher quality permitted limits to surface water by 1st May 2025.

Please provide NRW with updates as to when:

- planning permission is granted
- new PTP is installed
- the discharge to surface water commences
