4. Details of our assessment**CQA Plan – Cell 9 Gas Collection Infrastructure – Record of Acceptance**

The permit (condition 2.6.5) requires the operator to submit construction proposals, prior to the construction of any landfill infrastructure. Construction should not commence until Natural Resources Wales (NRW) has confirmed that it is satisfied with the construction proposals.

The operator has submitted construction proposals for the installation of gas collection infrastructure throughout Cell 9. The construction proposals consist of the following documents/submissions:

- Geotechnology Report: Withyhedge Landfill Site 2025 Gas Extraction Wells, Temporary Pin Wells And Temporary Horizontal Wells CQA Plan. Report Number: 2491r1v1d1124. Dated November 2024.
- Email from Eloise Critcher – Dauson Environmental Group. Dated 02nd December 2024 – 09:15. Subject title: RML - Gas Infrastructure CQA Plan - Cell 9.

NRW can now confirm that it is satisfied with the above submissions subject to the following caveats:

- The density of the gas collection infrastructure should remain consistent with the CQA Plan unless otherwise agreed in writing with NRW.
- The CQA plan includes proposals for 15 conventional gas wells (GW25/1 – GW25/15) which are to be installed in a phased manner as the waste mass in Cell 9 develops.
 - The operator will need to submit drilling details (survey levels and proposed drill depths) and acquire NRW approval for these gas wells in advance of their installation.
- The conventional gas wells should be installed as soon as final waste levels are achieved to maximise gas collection and minimise malodorous emissions.
- Once installed, gas collection infrastructure should be connected to the site's landfill gas extraction system as a matter of urgency, to maximise gas collection and minimise malodorous emissions.
- Monitoring and landfill gas management plans should be regularly updated to reflect the changes to the gas extraction system.

Please note that the acceptance of these CQA proposals, by NRW, does not mean that the assumptions, design specifications or testing regimes will be suitable for any future development at the site.
