4. Details of our assessment

CARS from generated follow site visit on the 05/11/24 at 10:00am as part of the SAC rivers project.

Met the general manager, the project manager and the sub contractor specialist who advises on the foul waste systems across Forest Holidays Ltd holiday parks in the UK.

I was shown the Sewage treatment system. All waste is piped into a holding tank where it is then pumped at a constant steady rate into the RBC (rotating biological contactor) for

treatment before being discharged to the Afon Colwyn.

A sample was not taken on this occasion as there was no discharge. The site was revisited on the 18/11/24 where a sample from the discharge was obtained.

The future permits are likely to get a limit of 5mg/L total Phosphorus. This is something you should take into consideration.
