4. Details of our assessment

This compliance assessment report has been raised in response to a Schedule 5 Notification and WIRS submitted by Knauf Insulation Limited. The incident took place between 1325 to 1920 on the 09/07/2024 followed by the site self-reporting a WIRS (2410323) later that evening followed by a Part A submission the following morning.

General management

At 1325 the thermal oxidiser for the mainline curing ovens went off, the bag filter remained operational. Production continued until 19:30 when it was noticed the thermal oxidiser was off, meaning for just over 6 hours there was partial abatement on emission point F.

Allowing the oven to run without the thermal oxidiser for 6 hours demonstrated a lack of sufficient management procedures. It also raises concerns around the other abatement systems at the installation. This has resulted in the following score:
