


**DISCHARGE CONSENT APPLICATION**

**RE: WATER RESOURCES ACT 1991, SCHEDULE 10 (AS AMENDED BY THE ENVIRONMENT ACT 1995) APPLICATION FOR CONSENT TO DISCHARGE TRADE EFFLUENT FROM PREMISES AT LLYN-Y-FAN TROUT HATCHERY, LLANDDEUSANT, LLANGADOG, NR. LLANDEILO. APPLICATION NO. BP 0278901.**

Further to your application the Agency has decided that consent should be given subject to conditions. I enclose the Agency's formal consent to discharge trade effluent from Llyn-y-Fan Trout Hatchery.

Under the present Scheme of Charges for Discharges to Controlled Waters an annual charge will be made for all consents to discharge, except where the discharge is of sewage effluent of five cubic metres or less per day. The charge is based on information derived from the conditions attached to the consent to discharge, as outlined in the enclosed leaflet.

If you consider that the conditions imposed by the consent are unreasonable you have a right of appeal to the National Assembly for Wales, Cathays Park, Cardiff, CF10 3NQ.

Notice of an appeal must be given in writing within three months of this notification and must be accompanied by a statement of the grounds of appeal.

If granted, a consent under Schedule 10 of the Act, covers water quality considerations only. It does not alter the need to obtain any other consents or approvals which might be required in connection with your proposal under other legislation. For example it does not give any right or permission to discharge where land is not owned by the applicant.

Please take careful note that if the holder of the consent changes, you must inform the Agency IN WRITING as soon as possible of the name of the new holder. This is to ensure that the rights and charges associated with the Consent are transferred to the new holder. A Certificate of Holder notice will be sent to you shortly which is designed for this purpose, and should be kept safely with the Consent until required.

## CONDITIONS OF CONSENT TO DISCHARGE

### FISH FARM EFFLUENT ("the Discharge")

**FROM:** LLYN-Y-FAN TROUT HATCHERY, LLANDDEUSANT, LLANGADOG, NR. LLANDEILO

1. (a) The Discharge shall not contain any poisonous, noxious or polluting matter or solid waste matter.
- (b) Provided that the Discharge hereby consented is made in accordance with the following conditions of this consent, such discharge shall not be taken to be in breach of condition (a) above by reason of containing substances or having properties identified in and controlled by these conditions.

### NATURE

2. The Discharge shall consist solely of trade effluent comprising treated fish farm effluent.
3. All water abstracted at the inlet for use in the fish farm must be passed through the point of Discharge and will be regarded as trade effluent.

### LOCATION

4. The Discharge shall be made in the manner and at the place specified as:
  - (a) discharging via a channel;
  - (b) discharging to the Afon Sawdde;
  - (c) at National Grid Reference SN 8029 2303;
  - (d) shown marked 'Consent Point' on Plan BP0278901 attached as Annex 1.

### SAMPLING POINTS

5. The inlet to the fish farm and the outlet to the watercourse shall be constructed and maintained so that a representative sample of the inlet water and the Discharge may be obtained at National Grid Reference SN 8031 2302 and SN 8029 2303 respectively, as shown marked 'Influent Sampling Point' and 'Consent Point' on Plan BP0278901.

## **VOLUME**

6. The volume of the Discharge shall not exceed 4800 cubic metres per day.

## **FLOW MEASUREMENT**

7. A flow measurement structure shall be provided and maintained to enable the daily volume of the Discharge to be measured or determined as required. Access to the apparatus for the purpose of taking readings must be available to Agency staff at any time.
8. Flow readings shall be taken by the consent holder at least monthly and records of the readings must be kept available for inspection by the Agency on request.

## **SCREENING**

9. The inlet to the fish farm and Discharge point shall be screened by means of simple mesh screens to the satisfaction of the Agency to prevent ingress of wild fish and escape of farm stock.

## **COMPOSITION**

10. Passage of water through the fish farm as measured by the difference in composition between samples of the inlet water to the fish farm and the Discharge shall not increase:
- (i) the biochemical oxygen demand (measured after 5 days at 20°C with nitrification suppressed by the addition of allyl-thiourea) by more than 2 milligrammes per litre;
  - (ii) the concentration of ammonical nitrogen (expressed as N) by more than 0.5 milligrammes per litre;
  - (iii) the concentration of suspended solids (measured after drying at 105°C) by more than 5 milligrammes per litre;
11. The Discharge shall exhibit a content of Dissolved Oxygen not less than 60% of air saturation, except where the influent waters have a lower concentration, that lower percentage shall apply to the Discharge as a minimum.
12. The pH of the Discharge shall not be less than 6 or greater than 9 pH units.
13. The Discharge shall not contain any material in quantities sufficient either directly or in combination with the river water to cause visible fungal growth in the receiving watercourse downstream of the Discharge.

14. The discharger shall notify the Agency in writing before using disinfectants, fungicides, biocides, pesticides, bactericides, detergents, antibiotics, growth hormones or other chemical and shall keep a record of the substance to be used, date and time of use, total amount used and period of dosing.
15. As far as is reasonably practicable, the fish farm shall be operated so as to prevent:
- (a) any matter being present in the Discharge, other than matter specifically covered by numerical conditions in this consent, to such an extent as to cause the receiving waters, or any waters of which the receiving waters are a tributary, to be poisonous or injurious to fish in those waters, or to the spawning grounds, spawn or food of fish in those waters, or otherwise cause damage to the ecology of those waters; and
  - (b) the Discharge from having any other adverse environmental impact.



**WATER RESOURCES ACT 1991 (AS AMENDED)  
USE OF MALACHITE GREEN**

As you will be aware Malachite Green is no longer available as an anti-fungal agent for use in aquaculture. In consequence the Secretary of State for Environment, Food and Rural Affairs has Directed the Agency to remove any permissions for discharge of that substance to controlled waters.

Your consent Number BP027890101 does not include a specific permission to discharge Malachite Green, but it does include a requirement for you to obtain the prior agreement of the Agency for the use of any chemicals that could present in any discharge. Under this condition the Agency specifically prohibits the use of Malachite Green at your fish farm. As a consequence of this notification you must immediately cease any discharge of Malachite Green.

The Agency recognises the need for use of anti-fungal agents. On a temporary basis to allow you to continue your business we are prepared to permit the presence in your effluent of substitute fungicides, subject to your strict adherence to manufacturers guidance and any guidance or instruction from other regulators such as Veterinary Medicines Directorate (VMD) and Food Standards Agency (FSA). This permission to use substitute fungicides shall remain effective only until such time as the Agency agrees your use of chemicals, as set out below. Further use of any chemicals after that time must only be made in accordance with the terms of the consent conditions.

Where the substitute is Pyceze, (bronopol), your strict adherence to the manufacturer's guidelines is expected to be sufficient to protect the environment and you may for the time being discharge the resultant effluent in admixture with your normal effluent, maximising its dilution as far as possible.

You will note that your consent requires the prior agreement of the Agency to the use of all therapeutic and prophylactic chemicals on your fish farm. The Agency has adopted this prior approval requirement as a more flexible and effective regulation of discharges of such chemicals to the environment than limiting concentrations in the discharge. The



approval will be a continuing agreement to specified chemicals in your effluent dependant on the specific method of use on your site. Note that the use of therapeutic and prophylactic chemicals for the treatment and husbandry of fish is a matter for VMD and FSA. You will not be required to seek agreement of the Agency for each occasion you wish to use agreed chemical treatments in accordance with your plan. These chemicals have the potential to affect the receiving watercourse and the Agency's aim is to ensure that your proposed use will not have any off-site effects.

However, this requirement will not prevent your use of therapeutic chemicals during the period from now until such time as the Agency agrees your proposed use. Provided you apply for approval, as set out below, the Agency agrees to your continued use of all current chemicals (except Malachite Green) for a period of six months from the date of this letter or until you receive Agency approval of your plan, whichever is the sooner.

You will need to seek agreement from the Agency for the presence in your effluent of any chemicals that you currently use either regularly or occasionally. To implement this process you should prepare a plan of your proposed usage of substitute fungicides and any other chemical treatments that you may wish to use on your site. These details should include the chemicals (trade name and active ingredients) you propose to use, how they will be used on your site (concentrations, location, etc) and how you propose to dispose of the chemical after use. For instance, the likely concentration of chemical in any treatment tank and its planned rate of flow into your final discharge flow. This plan should be sent to me at the address below by 17<sup>th</sup> July 2002. If the Agency is satisfied that your proposed use plan poses negligible risk to the environment then we will write to confirm that you may continue use according to your plan. If we are not satisfied then the Agency may request changes in your plan, and you will then be required to comply with those changes. Any such changes will normally be required only after discussion with you.

We expect that in the majority of cases it will not be necessary for us to impose numeric ~~limits on prophylactic and therapeutic chemicals. However, we reserve the right to do so.~~ If in the future you wish to change the chemicals that you use or the way you use them you must write to the Agency asking for agreement to the change in your plan. The Agency reminds you that using any chemicals other than in accordance with the conditions of your consent is an offence and may result in enforcement action. Our aim is to ensure that no discharges adversely affect the environment and to be able to demonstrate this to other river users. I am sure that as a river user you support this aim.

These changes will not affect your present liability to annual discharge charges. If you have any questions please contact me as soon as possible at the address below.
