4. Details of our assessment

Compliance visit carried out by two NRW officers accompanied by five DCWW operatives.

On the day of the visit the weather was cold and icy.

Site Report

The site appeared in good working order. The intake comprises a weir which due to the water levels wasn't visible. DCWW operative explained that the flow could be bypassed to conduct cleaning and maintenance which is now undertaken by the Dam safety team on a yearly basis. Residual flow only. There is a logger located at the site which records data.



Nant Y Bwlfa



This site has several inputs, again as per the previous site the weir was barely visible due to water levels. The pipe seen travelling across the river is from Nant y Moel reservoir. This input can be manually shut off if required. There is a small pipe on the right hand side coming from Nant Bodwigiad. These all feed in to a chamber where the water travels via gravity to Penderyn Reservoir.

Maintenance again is now undertaken by Dam safety on a yearly basis

Seven months of abstraction data have been received and verified to be within the allowable limit.
