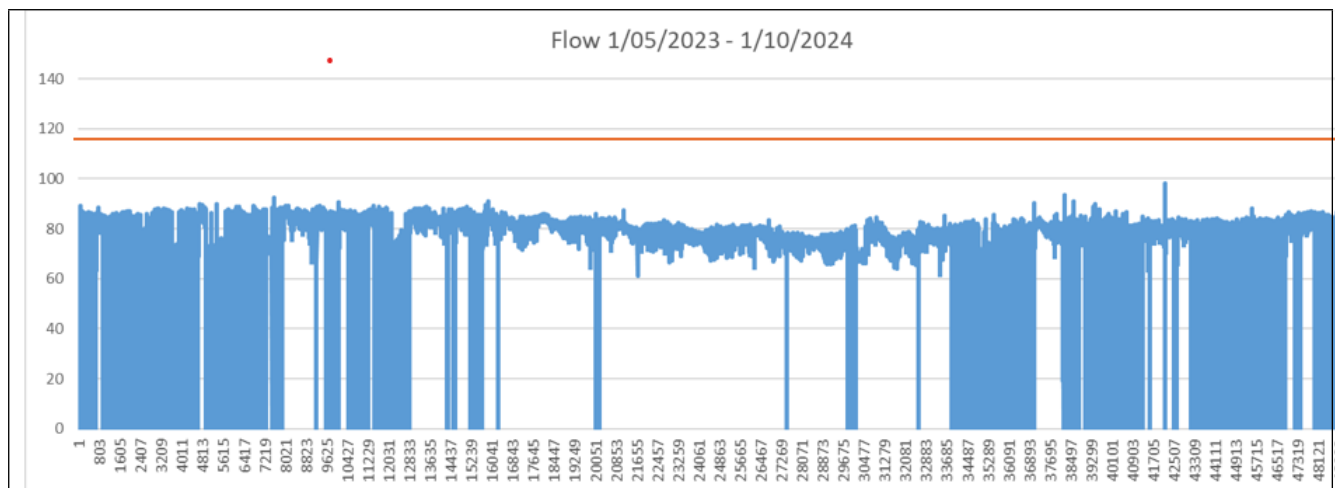
We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

Re issued on the 12/12/2024 with the correct permit condition

A data audit of the Pensarn SPS has been carried out by NRW. A permit breach of condition 4 has occurred where the pass forward flow (PFF) has been less than 115 litres per (L/s) second whilst storm discharges have taken place.

Below is a graph illustrating PFF data from 1st May 2023 - 1st October 2024.



Pass forward flow (PFF) for this asset is 115l/s before the asset is permitted to discharge. during this period PFF never gets above 90l/s as such our calculations are based on 90l/s for PFF, this is at least 25l/s which was not being passed forward. The orange line in the above graph depicts the permit condition of 115l/s of PFF before the asset is permitted to discharge.

In summary during the period May 1st 2023 to 1st October 2024, there was a total of 83250 recorded minutes of spills, this equates to $83250 \times 60s \times 25l/s = 124,875,000$ litres of settled sewage which has been discharged from the asset in breach of permit.

This pump station is required by permit to comply with Condition 2.3 (operating techniques) of passing at least 115l/s of PFF before discharging to the environment.
