4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards and Sally Wakeford of Natural Resources Wales. Officers were unaccompanied around site.

General Management - W1A

Under condition 1.1.1 (a) of the permit, the site is required to be operated in accordance with a written management system (EMS) which identifies and minimises the risks of pollution arising from operations.

It was noted by officers at the time of the inspection that operations on site were conducted well.

Action - Please provide a copy of the most recent Environmental Management System (EMS) for Natural Resources Wales records.

Waste Operations

Permitted Activities - W2A

On site operations at the time of the inspection were limited to composting, storing and mechanical treatment of aggregates as required under **condition 2.1.1 and Schedule 1, Table S1.1** of the environmental permit.

With composting activities taking place on an area of impermeable surface with sealed drainage.

Officers raised concerns with a mound of compost like materials at the rear of the site, and the potential for the leachate to enter the nearby stream given recent wet weather events, however, were notified that the materials in question were now PAS compliant.

As discussed on site, it is important to ensure that composts are stored appropriately to reduce the risk of potential environmental impacts. On this occasion officers did visually inspect the stream adjacent to the storage location, and it was found to be running clear with no signs of enrichment.

Action - Please provide NRW with records demonstrating the materials PAS certification.

Waste Acceptance - W2A

All wastes identified at the time of the inspection were compliant with **condition 2.3.2 (a) and schedule 2, Tables S2.2 and S2.3**.

The Site - W2D

All activities were conducted within the permitted boundary as highlighted in **schedule 7** of the environmental permit under **condition 2.2.1**.

Emissions and Monitoring**Odour - W3C**

Under **condition 3.3.1** the operations activities are required to be free from emissions from odour at levels likely to cause pollution outside the site, as perceived by an authorised officer of Natural Resources Wales.

At the time of the inspection, officers did not note any level of odours likely to cause pollution outside of the permitted site.
